You do the math...

- FACT 1: There are 842 sworn police officer positions in the City of Fresno. Fresno has 481,000 residents. This equals 1.75 officers per 1,000 residents.
- FACT 2: City officials have stated they could and would handle policing services to the 40,000 County residents who reside in the unincorporated islands within metropolitan Fresno with 5 to 6 officers. This equals 1 officer per 6,667 8,000 residents in the County islands. Therefore, in order to provide County pocket residents the same level of police coverage they currently provide City residents, the City would need to assign well over 60 police officers to the County pockets.
- FACT 3: Today, the Sheriff has 50 to 60 deputies assigned to the County pockets within the City limits compared to the 5 or 6 police officers the City is proposing for the same area.

Ask yourself, Why would you want to change who is currently protecting you, your family and your neighbors?
